CHEMTREC

CHEMTREC – Chemical Transportation Emergency Center is:

- 24/7/365 Emergency response call center providing service to Covestro
- Founded in 1971 as a public service of the American Chemistry Council
- Single point of contact for ACC member companies
- Provides initial emergency response guidance / assistance
- Hazmat shippers are required by law to provide immediate contact for incidents

CHEMTREC is NOT:

A regulatory agency

CHEMTREC does NOT:


- Contact / report incidents to a regulatory agency
- Contact / report incidents to local fire departments / emergency responders
- Cleanup the spill or send anyone in to cleanup the spill

- Stickers on rail tank cars and cargo tank trucks
- Carrier training drivers are instructed to call CHEMTREC

- Employee / driver exposure to product




