

# Statement on International Material Data System (IMDS)



The International Material Data System (IMDS) has been created to register automotive parts and polymeric materials. Under IMDS chemical raw materials are excluded from registration.

Covestro Deutschland AG and its affiliates register in IMDS sales products of polymers such as the following:

Since chemical raw materials are excluded from registration, chemicals for manufacturing polyurethanes cannot be registered in IMDS. However, Covestro can provide information required to register polyurethane materials or polyurethane containing parts.
