#### **Properties / Applications**

Arcol F-3222 polyol is a 3,200-molecular-weight triol used in the production of one-shot flexible urethane slabstock foams. The full range of flexible foams from extra super soft to extra firm, with varying densitites, can be made with Arcol F-3222 polyol. It provides an optimized balance of foam hardness, mechanical properties and processing ease, while maintaining yields. As with any product, use of Arcol F-3222 polyol in a given application must be tested (including but not limited to field testing) in advance by the user to determine suitability.

#### Storage

Arcol F-3222 polyol is slightly hygroscopic and may absorb water. Containers should be kept tightly closed and protected from contamination with moisture and foreign materials, which can adversely affect product quality.

This polyol can become quite viscous at low temperatures. For ease of handling, storage temperatures between 15°C (59°F) and 60°C (140°F) are recommended.

The shelf life is twelve months after receipt of material by customer, when stored in sealed original containers under conditions stated above.
