Particularly mixed with other Desmophen[®] products, Desmophen[®] 1262 BD is suitable for combination with many Desmodur[®] products in the formulation of low-solvent elastic coatings and adhesives.

Desmophen[®] 1262 BD can be thinned with solvents such as esters, ketones and aromatics. Only PU grade solvents should be used (< 0.05 % by wt. water).

Storage

- Storage in original sealed Covestro container.

- Recommended storage temperature: 15 - 25 °C.

- Protect from moisture, heat and foreign material.
